




Lake Wide Clean-ups: Fall and Spring Last 17 years








Recent Grants and additional Projects



The Deal Lake Commission was created by the seven Monmouth County, NJ towns that surround Deal Lake. The Commission was chartered in 1974 by the Borough of Allenhurst, City of Asbury Park, Borough of Deal, Borough of Interlaken, Village of Loch Arbour, Neptune Township, and Ocean Township.

BOATING CHECKLIST

- 1. Wear a life jacket.
- Make sure your life jacket is U.S. Coast Guard approved, appropriate for your water activity and fits properly.
- 3. Know state boating laws.
- 4. Take a boating safety course.
 NASBLA (National Association of Boating Law Administrators) approved boating safety course.
 Many courses are online, and will save you money on your boat insurance.
- 5. Make sure your boat is prepared.
- 6. Be sure to know your boat's capacity.
- Check the weather, including the water temperature.
- 8. Dress properly.
- Always file a float plan: floatplancentral.org
- 10. Always follow navigation rules.
- 11. Don't drink while you boat.
- 12. Beware of carbon monoxide poisoning.
- Keep in touch. Have several ways to communicate.















