OLD BUSINESS:

- 1. Flume Electrification Don Brockel, Commission Chairman, gave a brief update on the project. We are upgrading everything which will help us to have more positive control over the ocean coming into the lake at extremely high tides. We are also modernizing the flume gates. They will move up and down more easily and will be remotely controlled. He also explained the bonding for the project.
- 2. Interlaken to Loch Arbour Bridge Mr. Brockel said there is no update.
- 3. 319(H) Grant Dr. Stephen Souza, Commission Environmental Consultant, reported that Jack Szczepanski of Princeton Hydro, has prepared a memo to the DEP regarding the progress of the project. He met with the Sunset Lake Commission and they approved the locations of the two floating wetland islands. The plant materials are being purchased and will be installed in the Spring. Part of the Grant requires three informational breakfast meetings to be held. Mr. Szczepanski is working on setting up the first meeting for the beginning of December. Each Commissioner should reach out to their Mayor, Administrator, Director of Public Works and Planning Board Chairman to advise them of the upcoming meeting.
- Mr. Avakian, Commission Engineer, said he is working on the locations for the two MTD's.
- 4. Organic Material Removal from Fireman's Pond Mr. Avakian reported that Ocean Township will be doing the dredging project next year along with Monmouth County.
- 5. Water Testing: Monmouth University and Monmouth County Mr. Brockel announced that Monmouth University's Urban Coast Institute is hosting a Coastal Lakes Observing Network Workshop on November 1st at Monmouth University. There will be a recap of the data collected from Deal Lake. He hopes to have Dr. Adolf from Monmouth University come to the December meeting to discuss the results.
- 6. Ship & Sniff Program with Clean Ocean Action Mr. Brockel said he is still working with the people from the Ship & Sniff program to zero in on the problem areas.
- 7. Loch Arbour Tree Planting Project Mr. Brockel reported that the project has begun. The plantings are in and the trash cans and benches will be installed in the next few weeks. Once everything is completed he will schedule a walk around the project with Mr. Kassin.

Jeannie Toher, Asbury Park Commissioner, briefed the Commission on Asbury Park's plans for the east end of the lake. Nothing will start until the Spring.

8. OVER THE LAST FEW MONTHS, I HAVE MET ALL OF THE MAYORS THAT APPOINTED EACH OF YOU TO THE DLC AND I ATTENDED 6 OF THE 7 COUNCIL MEETINGS AND MADE MY REQUEST PUBLIC DURING THE PUBLIC PORTION OF THEIR MEETING. The State of Deal Lake Report - 2007 - Preliminary - 2/21/2008

SUMMARY OF CONCLUSIONS

The environmental state of Deal Lake is extremely poor. Pollutants exceed state mandated levels. In many sections of the lake the water is unfit for human contact.

Western sections of the lake are in desperate need of organic material removal and dredging. Many areas will be filled in within 10 years if proper maintenance is not funded and performed.

The Deal Lake Commission's budget is inadequate to meet basic maintenance needs of the lake. The Commission's budget needs to be increased at least two fold, preferably three. Local municipalities will be asked to provide additional funding even though this may be difficult due to budget cap restrictions. Monmouth County Freeholders will be requested to match the contributions given by each local town. Actually, county taxes generally match local government taxes so this makes sense for the county to support the Commission on an equal basis. And finally, the State of New Jersey must provide annual funding for Deal Lake similar to the funding given Lake Hopatcong. This would allow the Commission to establish annual maintenance projects and fund necessary studies.

Stormwater regulations now require municipalities to clean storm basins on a regular basis. No requirement has been made to require periodic cleaning of the areas of the lake where streams and large outfall pipes transport large amounts of silt and debris. Several areas of the lake, especially in western sections, need to be reclassified as regional stormwater basins and the DEP needs to create an easy permit process for cleaning.

The State of New Jersey and Monmouth County must assume the responsibility of providing disposal sites for organics (weeds and leaves) and dredge spoils removed form the lake.

The highway infrastructure needs several large basins to retain stormwater to help control flooding, stream scouring, and silt migration. Studies must be funded to determine the best locations and best methods to build several large regional stormwater retention basins.

Due to the lack of large stormwater retention basins in the watershed, the Commission and local municipalities are forced to regulate the lake level by opening and closing the flume gates during major rain events. Electrification of the flume gate mechanisms is a mandatory project.

The flume protective grate needs to be redesigned to minimize the formation of debris dams. A secure catwalk needs to be added so workers can safely remove debris from the grate. The current grate could allow a small logs and boards as well as debris and floatables. Should a debris jam ever occur within the flume itself, the most serious flooding to properties around Deal Lake could occur.

Human fecal coliform is finding its way into Deal Lake. Local and county health departments could team with university students to test outfalls and identify possible leaky sanitary sewers.

Sections of the lake bulkhead located in Asbury Park, Loch Arbour, and Interlaken are in need of repair or replacement. Vegetation growth on and in the bulkhead must be removed and an annual herbicide program be established.
