OLD BUSINESS

1. 2107 – 319(H) Grant – Don Brockel, Commission Chairman, reported that the contracts are signed and all of the paperwork has been received from Precise Construction, the contractor doing the rain gardens. We have received the extension of the Grant from the State of New Jersey until the end of April. We are hoping to have the project complete by then, if not we will ask for another extension until the end of September.

Peter Avakian, Commission Engineer, said that the contractor is ready to mobilize as soon as the weather permits. He gave a brief explanation of the construction timeline and again gave the locations for the rain gardens. There will also be a tree box installed in Allenhurst.

- 2. 319 Grant Phase I with NJIT No Update
- 3. Nobility Crest Mr. Brockel reported that there are no updates but the Township of Ocean Board of Adjustment voted down the senior facility that was planned for by the entrance to Cedar Village. If the development had passed it would have a tremendous impact on Deal Lake. He wanted to thank and acknowledge all of the residents that attended the zoom meetings to voice their concerns.

Jeannie Toher, City of Asbury Park Commissioner, read from a prepared statement, once again asking if the DLC Attorney ever sent a letter to the Attorney General asking them to enforce the clean water act against Nobility Crest.

Hunt Parry, Deal Lake Commission Attorney, explained that the letter was not sent. At the time he couldn't get any information from the file due to COVID. The municipal offices were closed. The alternative was to send a letter to Nobility Crest and their Attorney, which was done. All of this was explained to the Commissioners at that time.

- 4. Shoreline Protection/Education Mr. Brockel asked Ms. Toher to go over the two actions that were discussed today during a meeting between Dr. Souza, Jeannie and him. Ms. Toher said they talked about creating a boiler plate form to be attached to construction permits for the towns that would say any work conducted on Deal Lake waterfront may need additional permits from NJDEP. They also discussed giving the construction departments from the various towns the pamphlets that we did on the lake to residents that come in for permits.
- 5. Goose/Carp Remediation Mr. Brockel said each town should be getting a letter about nests and who to alert from USDA. Surveillance starts next month of the shorelines.

Melanie Nowlin, Alternate Commissioner from Loch Arbour, spoke to someone from the Raptor Association and they are interested in taking the carp.

- Dr. Souza said the best approach would be to have some of the fisherman from Belmar come and get the carp or farmers in the area that want to use them as organic fertilizer.
- 6. Clean Water Action Mr. Brockel and Dr. Souza met with CWA a few weeks ago to discuss our plan of action. We need to wait until more residents are in town to do more testing.
- 7. Restoration of 4 lakes/ponds west of Wickapecko Mr. Brockel reported that Ocean Township will be dredging Fireman's Pond and the back of Terrace Pond by the golf course.
- 8. Water Testing: Monmouth University Dr. Adolf will be holding a Workshop prior to the Regular DLC Meeting on April 21s to discuss his most recent water testing results. His presentation will begin at 6:15 pm. Dr. Souza will co-present with Dr. Adolf.
- 9. New DEP Stormwater Management Grant Mr. Brockel explained that it's a slow-moving process. He and the CFO have a meeting with the Grant people on March 7th to go over the procedures and the contract. We don't anticipate getting the contract for at least six to eight months.

Mr. Avakian and Dr. Souza would like to do a presentation in a month or two that would give a brief overview of what the project entails.

10. JCP&L Violation – Mr. Brockel has received an answer to his OPRA request from the State regarding the Notice of Violation that was sent to JCP&L. Once he and Dr. Souza review it they will determine what the next move will be.

NEW BUSINESS

1. 2023 Algaecide and Herbicide Treatment – Dr. Souza needs to make some slight modifications to the proposal for this year's treatment.

There was a brief discussion on last year's treatment. We'll be treating the same areas that we did last year. The treatment can't start before April 1st. We are looking to do the treatment in late May, early to middle of June.

Resolution #23-022 – Authorizing Requests for Proposals for the 2023 Algaecide and Herbicide Treatment at Select location of Deal Lake

UPON MOTION of Ocean, seconded by Neptune, carried that the following Resolution be and the same is hereby adopted:

WHEREAS, there exists a need for a herbicide treatment of Deal Lake in the Colonial Terrace and Hollow Brook Cove section of Deal Lake.

NOW, THEREFORE, BE IT RESOLVED by the Deal Lake Commissioners that it hereby authorizes the Commission Clerk to advertise the Requests for Proposals for the 2022 Herbicide Treatment at select areas of Deal Lake.

2. Shared Services Agreement between the Deal Lake Commission and the Township of Ocean for Commission Clerk and Chief Financial Officer Services – Mr. Brockel gave a brief explanation of the Agreement and said that instead of paying the Commission Clerk and CFO directly for their services the DLC will now pay the Township of Ocean and they will pay the Commission Clerk and CFO. It will go through the Township's payroll system.

Resolution #23-023 - Authorizing a Shared Services Agreement between the Deal Lake Commission and the Township of Ocean for Commission Clerk and Chief Financial Officer Services

UPON MOTION of Asbury Park, seconded by Interlaken, carried that the following Resolution be and the same is hereby adopted:

WHEREAS, the Deal Lake Commission requires the positions of Commission Clerk and Chief Financial Officer to be filled and the Township of Ocean has a Registered Municipal Clerk and a Chief Financial Officer, which they are willing to provide to the Deal Lake Commission in a Shared Services Agreement; and

WHEREAS, the Township of Ocean is able and willing to provide said services to the Deal Lake Commission for one (1) year from January 1, 2023 through December 31, 2023 with optional two (1) year renewals; and

WHEREAS, the Deal Lake Commission agrees to pay the Township of Ocean the sum of Twelve-Thousand Five-Hundred dollars (\$12,500.00) per annum for the 2023 Calendar year with no annual increase for the second and third year optional (1) year renewals for 2024 and 2025;

NOW, THEREFORE, BE IT RESOLVED by the Commissioners of the Deal Lake Commission that the Commission Chairman and the Commission Clerk are hereby authorized to execute and deliver the Inter-local Services Agreement between the Deal Lake Commission and the Township of Ocean for Commission Clerk and Chief Financial Officer Services for one (1) year from January 1, 2023 through December 31, 2023 with option two (1) year renewals; and

BE IT FURTHER RESOLVED that said Agreement will be maintained by the Deal Lake Commission and the Township of Ocean and will be available for public inspection during regular business hours; and

BE IT FURTHER RESOLVED that a certified copy of this Resolution shall be forwarded to the following:

- 1. Chief Financial Officer Township of Ocean
- 2. Municipal Clerk Township of Ocean
- 3. Deal Lake Commission

- 3. Mr. Brockel reported on a project in West Allenhurst that is over 30 acres that has applied for a Wetlands Delineation Report. The property is located between Roseld, Wickapecko, Milwin Farms and the Golf Course. There is no much information or plans for the property right now but we need to keep an eye on it, as it would affect the lake.
- 4. Lollipop Pond Mr. Brockel said there was a lot of action over at Lollipop Pond.

5. Mr. Brockel reported that construction has begun over at the old Coke plant and they seem to be complying with the stormwater rules.

COMMISSIONER'S LAST WORD

Carolyn Roarty, Interlaken Commissioner, is doing a follow-up from last month's meeting where she offered to report on what she observes around the lake. This month she spoke about a great app for people who walk around the lake. It's called Merlin and when you download the app it brings up a list of birds that are indigenous to the area at different seasons throughout the year. She went on to announce that there is a wayward canoe on the western side of the railroad bridge. Don has posted it on Faceook.

Jeannie Toher, Asbury Park Commissioner, is grateful to all of the Commissioners for their support of the Deal Lake Commission working with the USDA for goose remediation this year.

Bruce Fromer, Allenhurst Commissioner, has noticed a large quantity of geese – let's stay on top of it.

Eric Houghtaling, Neptune Commissioner, reported that Neptune has completed a living shoreline on their portion of the Shark River. It might be something that could be used on Deal Lake.

Eddie Winder, Alternate Asbury Park Commissioner, spoke briefly about the "Billion Oyster Project" that he is involved in New York. He is hoping to get the project here in New Jersey. If the oyster reefs were in place before Super Storm Sandy, Staten Island and Coney Island would have been spared from the disaster that occurred.

Melanie Nowlin, Alternate Loch Arbour Commissioner, said Loch Arbour is still pushing for a tree ordinance.
