

NOTICE TO BIDDERS

**BID LEGAL NOTICE
WATER QUALITY IMPROVEMENTS GRANT IN THE
DEAL LAKE WATERSHED, MONMOUTH COUNTY**

Notice is hereby given that sealed bids will be received by the Deal Lake Commission for "Furnish and Deliver Manufactured Treatment Devices for the Deal Lake Commission Water Quality Improvements Grant in the Deal Lake Watershed, Monmouth County, New Jersey" at the Township of Ocean Municipal Building, 399 Monmouth Road, West Wing Conference Room, Oakhurst, New Jersey 07755 at 10:00 a.m. prevailing time on Friday, April 24, 2026 at which time they shall be opened and read aloud.

Work shall consist of the purchase and delivery of six (6) stormwater treatment devices and an alternate bid for an additional two (2) stormwater treatment devices should funding allow as per the specifications included herein. Funding for this project is through the NJDEP Water Quality Improvements Grant. A separate bid for the installation of the treatment devices, provided under this contract, will be forthcoming.

The specifications for the proposed work, prepared by Leon S. Avakian, Inc., Consulting Engineers, 788 Wayside Road, Neptune, New Jersey may be examined at the office of the Engineer during business hours. Bidders may obtain one copy thereof upon proper notice and payment of a non-refundable charge of \$100.00 to defray the cost thereof. Checks shall be written to the order of Leon S. Avakian, Inc. for each set of documents.

Bids must be made on the standard proposal form in a manner designated therein and required by the specifications. They shall be enclosed in an opaque sealed envelope addressed to the Deal Lake Commission bearing on the outside the name of the bidder, his address and the name of the contract for which the bid is submitted. Bids must be accompanied by a certificate from a surety company stating that it will provide the specified performance and maintenance bonds in the event that the contract is awarded to the bidder.

Each bid must be accompanied by a certified check, cashier's check, or bid bond for ten percent of the amount of the bid, not to exceed \$20,000, drawn upon an incorporated bank or trust company, payable to the Deal Lake Commission, as guarantee that in case the contract is awarded the bidder, he will, within ten days thereafter execute such contract and furnish satisfactory performance bond. Upon failure to do so, he shall forfeit the deposit as a partial satisfaction of liquidated damages and the acceptance of the bid will be contingent upon fulfillment of this requirement by the bidder. The checks of all bidders will be returned according to law. No interest shall be allowed upon any such check.

Bidders are required to comply with the requirements of P.L. 1975, c.127., N.J.A.C. 17:2.(Affirmative Action) and P.L. 1977, C.33 (Ownership Disclosure).

The Contract shall be awarded, or all bids rejected, within sixty days from the receipt of bids or within such extensions of time as permitted by law.

The Commission reserves the right to reject any and all bids, or to waive any informality of any bid.
